

Evaluations can be costly. It is critically important that they are done correctly on the first visit.
Our team is here to help and support the process of getting the right evaluation you need, the first time you go.

What to know before you go:

- Evaluations for the monitoring program must be completed by a licensed masters level clinician or higher.
- Initial evaluations must be completed for both Mental Health and Substance Use Disorders.
- Only individuals with a diagnosed Mental Health and/or Substance Use Disorder are eligible for HPSP.
- Evaluations when completed must include treatment and return-to-work recommendations.

Note: Inpatient evaluations must be completed in-person. "Virtual inpatient evaluations" are not acceptable.

Tips:

- When making first contact with an evaluator, inform them that you are seeking an evaluation as a licensee of the Oregon Medical Board.
- Tell them that you are looking to obtain an evaluation with an approved evaluator that is a licensed, masters level or higher, clinician that will use ASAM criteria.
- If the facility or evaluator does not seem certain of what the requirements of this evaluation are, reach out to our program before scheduling or attending an evaluation.
